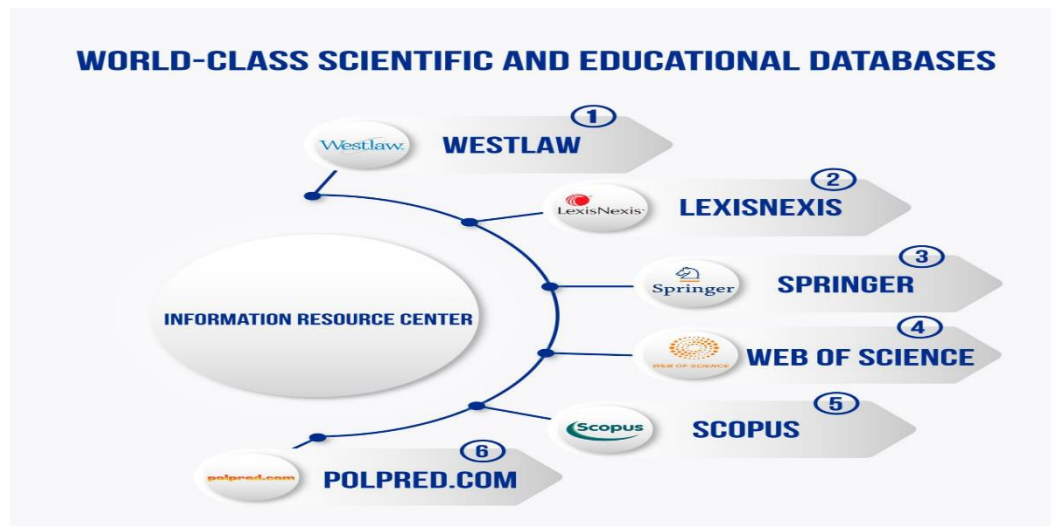
### *Open Doors to Knowledge: On-Campus Public Resources*

Our Information Resource Centre (IRC) serves as the primary hub for public access, welcoming all visitors to utilize its state-of-the-art facilities.

  - Our **Information Resource Centre (IRC)** is the academic core of TSUL. This 24/7 facility is a testament to our commitment to providing unparalleled academic resources.

    - The Ministry of Higher and Secondary Specialized Education launched the [unilibrary.uz](#) electronic library platform, which hosts around 200,000 educational, scientific, and other publications with continuous expansion. The

- A Vast Collection: The IRC houses over 300,000 resources, including 100,000+ course books and 100,000 scientific books.
- Global Digital Access: We provide access to premier international legal and scientific databases, including [Polpred](#), [ScienceDirect](#), [Westlaw](#), [LexisNexis](#), [Springer](#), and [Scopus](#).



- A Space for Learning: With 248 seats, modern computers, and high-speed Wi-Fi, the IRC offers a quiet and well-equipped environment for research and study.



- **Computer Systems**: Modern computers connected to international databases are available for “all visitors” to use.

- **Free Wi-Fi Access**: High-speed internet access is available for “all visitors of TSUL Library”.
- **E-Library Access**: Our comprehensive online platform provides public access to a vast collection of books, manuals, monographs, and scientific works.
- **Bookshop**: The TSUL Shop, located in Building No. 3 of Tashkent State University of Law, offers a variety of promotional merchandise, from clothing to practical items, with proceeds supporting projects for students and staff.
- **English Language Centre**: Our university offers an intensive IELTS preparation course with expert instructors to help students improve their English skills in Speaking, Writing, Reading, and Listening.

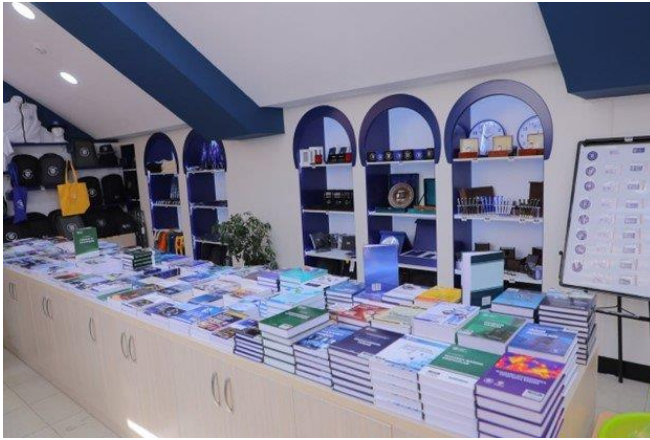
